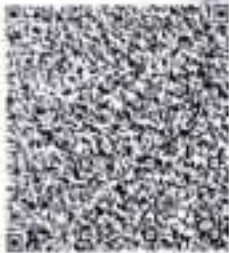

Mirzapur, U.P., India - 231307, Mob:- 9031440444** hereinafter called the "Founder", (which term shall unless excluded by or repugnant to the context, include his heirs, successors, executors, administrators and legal representatives) of the first part and the Founder Trustees (which terms shall unless excluded by or repugnant to the context, shall include the Trustee for the time being at present and the survivor or survivors of them and their respective successor or successors thereafter) mentioned hereinafter of the other part.

Whereas the Founder out of philanthropic benevolent and other good, pious and noble causes, has already set apart a sum of Rs. 10,000/- (Rupees Ten Thousand only) in cash toward constituting a Educational & Public Charitable Trust and handed over the same to the Trustees hereinafter appearing.

AND WHEREAS the Trustees have agreed to become the First Trustees, and have also accepted the Trust Fund as stated above.

AND WHEREAS it is necessary to declare the objects and terms of the Public Charitable Trust.

NOW THIS DEED DECLARATION OF THE PUBLIC CHARITABLE TRUST WITNESSES AS FOLLOWS :

1. **NAME OF TRUST :-**

This name of the Trust shall be " **Pragati Darshan** " hereinafter for the sake of brevity referred to as "Trust" and its **Head Office** shall be at **Vindhyachal, Dist. Mirzapur, U.P., India-231307.** and branch (as) at such other place of places as the Trustees herein may decided from time to time.

2. **FOUNDER :-**The following members shall be the Founder Trustees of the Trust, who will be lifelong trustees :

3. **PRESIDENT :-**

- (a) The president will hold office for life Anshu Kumar will be the President, followed by his wife. After that the office of the President shall be assumed by the eldest son of the last President.
- (b) In case the eldest son is minor, then his legal guardian shall be in charge of the President till the attainment of the age of the majority of the eldest son. In case of no son, the eldest male member of the family will be legal heir to the Post President.

4. **TRUSTEE (Member):-**

- (a) The Member will hold office for life shall be Trustee.

5. **TRUST FUND :-**

- (a) The initial contribution of Rs. 10,000/- (Rupees Ten Thousand only) made by the Founder of the Trust shall hereby vest in the Trustees and shall constitute the initial Trust fund.
- (b) The trust fund may be augmented by the income from the initial fund and also donations and other contributions from time to time.
- (c) The Trust fund can be applied for any charitable purpose in addition to those specified below.

6. **OBJECTS OF THE TRUST :-**

The objects of the Trust are as under :

- (a) To open, found, establish, promote, setup, run, maintain, assist, finance, support and/or running hospitals, charitable dispensaries, child welfare centers, research centers, diagnostic center, blood bank, service centers, immunization centers, health centers and to apply or provide utility articles and service to patients, attendants and others and to provide medical relief and/or aid to the suffering humanity.
- (b) To establish, setup, maintain, finance support and/or help in the setting up orphartges, widow homes, old age homes, old age homes, lunatic asylums, leprosy centers. AIDS relief centers of other establishments for relief and/or help to the poor old and/or destitute, disabled, distressed, handicapped and sick persons.

- (c) To Start Digital India , Yoga Classes & Certification ,Swaksh Bharat Abhiyan , NITI aayog Charity ,12A, 80G.
- (d) to give, provide and/or render monetary and/or other help and assistance for the relief of persons and animals affected by natural and other calamities such as flood, fire, famine, cyclone, earthquake, storm, accident, drought, epidemic to give donations, subscriptions or contributions to institutions, establishments doing relief work on such occasions.
- (e) To promote, advance and encourage and/or aid in helping, promoting, advancing and fire and Safety Training ,Certification & Safety Placement, also physical training of handicrafts, fine art and other useful arts, crafts among the public including the establishment and maintenance of Kala Kendra and other welfare centers for them.
- (f) To open, found, establish, promote, setup, run maintain, assist finance and/or help in the setting up and/or running school, colleges, and other establishment or institutions for advancement of education and of knowledge in science and literature, training colleges, law colleges, technical and medical college, and colleges and institutions for humanities and other useful subjects.
- (g) To promote/incourage career-oriented education and training in handicrafts, fine arts and the skills among people in general and establish and found institutions imparting such education and to establish maintain support or help by monetary gifts or otherwise to centers and institutions for women, men and children and to provide for social welfare works for men, women and children.
- (h) To grant, pay or give scholarship, stipends, prizes, rewards, allowances and other financial assistance or help in cash or kind to students with a view to help them in pursuing their studies in schools, colleges, whether in India or abroad and to education institutions, technical institutions, art schools, institution teaching commercial and other arts.
- (i) To open, found, establish, promote, setup, run, maintain, assist, finance, support and/or aid or help in the setting up and/or maintaining and/or running by monetary gifts or otherwise centers, stadiums, play grounds and parks for public use, sports and games and other social welfare works and/or activities.
- (j) To open, found, establish, promote, setup, run, maintain, assist, finance, support and/or aid or help in the setting up and/or maintaining and/or running institutions, centers, libraries, auditoriums and the like for the running of welfare and other services to the public and to provide meeting room for socially useful activities and functions.
- (k) To open, found, establish, promote, setup, run, maintain, assist, finance support and/or aid or helping the setting up and/or maintaining and/or maintaining Old Age Home, Selter Home, University, College, Nursing School, Pharmacy College, Degree College, 10 and 12th CBSE School , Play School,
- (l) To promote, organize, administer, support, maintain and/or grant aid to any person, institution or organization whatsoever having for its objects or charitable, assist or organization whatsoever having for its objects or charitable purpose and to incur expenditure in connection therewith.
- (m) To promote, assist and/or maintain all activities by whatsoever carried or wherever carried on in India in conformity with the objects of the Trust.

- (n) to help in the preservation of environment and useful animals including opening and maintaining Goat Farming and to promote plantation and ecological conservation.
- (o) To provide help, assist in cash or in kind the poor families and to provide food shelter or clothing as well as to give financial assistance for the marriage of needy and poor girls.
- (p) To carry out programs for welfare of weaker section of the society and also for the development of backward and rural areas of the country.
- (q) To assist deserving unemployed persons for setting up their own cottage industry, business or vocation etc. to enable them to earn livelihood for self and their families.
- (r) To donate, help, pay any other public charitable and religious trusts for promoting to objects of trust.
- (s) To take over or amalgamate with any other charitable trust, society, association or institution with similar objects.
- (t) To set up, found, open institution for training unemployed persons and to open institution for meditation, yoga and pranayam, peaching and propagation of philosophy and institution for music and fine arts, conduction school for imparting education of music and dance, holding music concerts, dance recitals.
- (u) To set up, help advancement of producers in India and to improve status of farming community.

7. ENABLING POWERS :-

That for the furtherance of the objects of the Trust, the Trustees shall have the following power through their Managing Committee:

- a. To accept any donation, contribution, grant of subscription in cash or in kind, from any persons(s), body of persons or Trust institutions, State or Central Government, Semi Government Departments, Local Authorities etc. with or without condition.
- b. To apply the whole or any part of the income of the Trust or the Trust Fund or accumulation thereto to any one or more of the objects of the Trust, as the Trustees may, in their discretion deem fit from time to time.
- c. To Receive Foreign Found , National Fund, Donation , Gateway website, world Bank , Agriculture Bank, Micro Financial bank .
- d. To invest Trust fund either in the purpose of mortgage of immovable property or in Shares, Stock or Debentures or any other Securities and Investments, or ink Deposits with or Loans to any Company, Bank, Firm or any other person and to alter, vary or transpose such investments from time to time at the discretion of the Life Trustees.
- e. To borrow or raise or secure payment of money and also to lend money either with or without security.
- f. to sell, dispose off, alienate or otherwise deal with any property comprising the Trust fund.
- g. To let out, demise any immovable propefty, comprised in the Trust fund for such period and at such terms and conditions as the Life Trustees in their discretion may think fit.
- h. To open account in the name of Trust, and institutions run/conducted by the Trust, with a bank or banks, to operate such accounts and to give Private & Govt. Bank. [

- instructions to the bank and to provide for the opening and operation of such account jointly by the President and the Secretary.
- i. To adjust, settle, compromise, compound and refer to arbitrations, all actions, suits, claims, demands and proceedings regarding the Trust fund.
 - j. to make, vary alter or modify schemes, rules and regulations for carrying out the objects of the Trust and for the management of the affairs, thereof, and/or running any institution in furtherance of the objects of the Trust and otherwise or giving effects to the objects of the Trust.
 - k. to appoint or make provisions for the appointment of any person (including all or any of the Life Trustees and committees or administration of the Trust in such manner and subject to such rules and regulations as the Managing Committee may prescribe and also to appoint or provide for appointment of separate Trustees to hold any fund or investment subject to the provisions of the Trust in such manner and subject to such rules and regulations as the Managing Committee may from time to time fit.
 - l. To start, abolish, discontinue and restart any charity or charitable institution for the benefit or general public and to impose any condition to any subscription or donation made by them.
 - m. To Start Blood Donation Camp, Blood Donation Member Group, Self Help Group , SHG , Cooperative Work for Charitable Purpose.
 - n. To give aid by way of donations out of the income or the corpus of the Trust fund or otherwise to different charitable institutions, societies, organizations or Trust in India which may have been established or which may hereafter be established for like charitable purpose mentioned in these presents or any of them to enable such institutions, societies, organizations or Trustees to start maintain or carry out such charitable objects.
 - o. To apply to the Government, Public bodies, Urban, Local Municipal District and other bodies, Corporation, Companies, or Persons for and to accept grant of money or aid, donations, gifts, subscriptions and other assistance with a view to promote the object of the Trust and to discuss and negotiate with the Government Departments, Public and other bodies Corporations, Companies and Persons, Scheme and other work and matter within the objects of the Trust and to confirm to any proper condition upon which such grant and other payments may be made.

6. **Types of Membership :**

- (a) **Founder Trustees** : The members, whose names have been incorporated in the Trust Deed
- (b) **Life Trustees** : The members, who are in blood relations of the Founder Trustees and who have been admitted for life.

(c) **Ordinary Members** : The members, who have been admitted by the president on the recommendation of Founder Trustees (and in their absence by life Trustees) for the benefit of the Trust, but who will have not voting rights, and whose appointment shall be valid for 5 years only, Their membership may be renewed on the joint recommendation of the President and the Secretary (Manager).

8. **No. of Trustees** : Maximum 9 (Nine)
: Minimum 1 (One)

9. **No. of Ordinary member** :- Maximum – 11
:- Minimum – 1

10. **Eligibility of the Members:**

No Person being-

- (a) an undercharged insolvent : or
(b) convicted offence involving moral turpitude : or
(c) of unsound mind : or
(d) a minor shall be eligible to be Member.

11. **Ceasing of the Membership :**

A person shall cease to be member in any of the following events :

- (a) if he/she dies :or
(b) if he/she becomes bankrupt: or
(c) if he/she becomes insane or otherwise incapable to actor
(d) if he/she resigns his office, and the resignation is accepted by the President.
(e) if he/she works against objects of the Trust in the Opinion of Majority of Life Trustees.

13. **MEETING :**

General meeting of the Managing Committee shall be held at least once a year. However, with the consent of the President, meeting can be called upon at any time by Trustee.

14. PERIOD OF NOTICE:

The notice shall be of minimum one Month. However, it can be reduced on the event of any emergency, with the consent of the President.

15. QUORUM :

The Founder always decided any Type of Work and Development for Social Justice and Justify for Trust Member Committee.

16. FOUNDER DUTIES & RIGHTS OF THE MANAGING COMMITTEE :

- (a) Nomination of the vice President, Deputy Secretary and members.
- (b) Modification of the Constitution of the Trust by 3/4 majority.
- (c) To take decision in respect of opening of hospitals, schools, graduate and post-graduate colleges, engineering/management/law/teacher education colleges.
- (d) Managing committee shall have right to form sub committees as needed for any purpose in which all members of the managing committee shall be the member of sub committee. For running any education institution established by the Trust, where it is required to form a management committee, the President and Secretary of the trust shall be the President and Secretary of the committee of the institution respectively. The remaining office bearers (Vice-President, Treasurer and Members) of that committee shall be elected by the Trustees for a period of five years. These members will be for Life Trustees or from the ordinary members, they will have no voting rights. However, they can provide their opinion to run the institution and shall participate in the meetings.

17. Founder :

- (a) The President will hold office for life. Sri Anshu Kumar will be the president, followed by his wife. After that the office of the president shall be assumed by the eldest son of the last president.
- (b) In case, the eldest son is minor, then his legal guardian shall be in charge of the President till the attainment of the age of the majority of the eldest son. In case of no son, the eldest male members of the family will be the legal heir to the post of President.

RIGHTS & DUTIES OF THE PRESIDENT (Founder) :

- (a) The Founder will be Chief Executive / Chair Person of the trust.
- (b) The President shall preside over the meeting of Managing Committee.
- (c) The President will solely operate all banking Transaction of Concern Trust.

- (d) The President's Committee/board of the Trust or the institutions run by the trust is divided equally on any resolution in the meeting or on any decision, the president is entitled to the second or casting vote.

18. **MENTOR :**

The Mentor shall supervise the overall functions/management of the trust. In absence of Mentor, the President will act Mentor.

19. Proper accounts of the Trust shall be kept at the Head Office/ Regional Office /Registered Office the trust.
20. The Managing Committee member will not be entitled to receive any remuneration, but the Managing Committee may reimburse themselves all expense actually incurred by them, in connection with the . .
21. The number of members of the Managing Committee shall not be less than two and more than seven. If the number of the members shall fall below two, the Trustees shall not, except for the purpose of filling any vacancy, at so long the number is below the said minimum.
22. Every Trustee will be at liberty to resign on giving one month's notice of his/her intention of doing so
23. The Managing Committee shall from to time frame rules for the conduct and regulations of the meeting of the Trustees. In the absence of such regulations
- (a) All matters will be decided mutually by the Managing Committee.
- (b) Resolution passed without any meeting of the Managing Committee, but by circulation thereof and evidenced in writing under the hand of 1/ 2 of the trustees including the President shall be as valid and effectual as a resolution duly passed at a meeting of the managing committee.
24. The accounting year of the Trust shall by the financial year ending on 31 March every year.
25. The Trust and Trust funds shall be irrevocable for all times.
26. The object and/or By-laws of the Trust can be altered or modified or change within the charitable purpose by 3/4 majority of the Trustees in Ordinance member for general meeting.
27. It is explicitly declared that no of Trust property or its income or any accretion thereto shall be applied for any purpose outside India or for the benefit of any Trust/Member or any purpose which is not a chartable purpose in law and all provisions thereof shall be construed accordingly.
28. In case of dispute, the place of jurisdiction will be District Mirzapur U.P. (India).
